

Regulations of Bike Adventure 2023

1. PURPOSE OF THE EVENT:

- Promotion of healthy lifestyle through MTB cycling on the most interesting routes in Karkonosze and Izerskie Mountains.
- Promotion of Szklarska Poręba as a place to practice mountain biking.
- To select the best riders in a four-stage MTB marathon.

3. DATE AND VENUE:

29.06 - 02.07.2023 – Szklarska Poręba

4. STAGES:

Bike Adventure PRO 2023 - is a 4-stage MTB race, the expected length of all stages is about: 240 km, the number of elevation about 7450 m.

Bike Adventure CLASSIC 2023 - is a 4-stage MTB race, the expected length of all stages is about: 120 km, total elevation about 3800 m.

5. CONDITIONS OF PARTICIPATION:

Participants of Bike Adventure 2023 - adults only. Bike Adventure CLASSIC - nonadults (U18) are allowed if they have a statement of a parent or legal guardian) All participants must meet the following criteria:

- 5.1. Fill out the online application form www.datasport.pl
The deadline for submitting your application to Bike Adventure 2023 is 11/06/2023.
- 5.2. **Pay the entry fee** in the amount according to the regulations.
- 5.3. **Collect the participation package in the Race Office before stage 1.**
The Race Office will be open :
28.06.2023, 17:00 – 20:00,
29.06.2023, 9:00 – 12:00.
- 5.4. **Each participant takes part at his/her own risk** (in the case of underage competitors at the risk of their parents or legal guardians).

- 5.5. **Each rider must wear a helmet during all race.**
- 5.6. The race is entered in the calendar of the Polish Cycling Union (PZKOL/UCI).

6. TIME KEEPING:

There will be an electronic system of identification and timing of the competitors.

- starting fee for a lost or damaged starting number – 30 PLN (10 EUR)

After paying the entry fee, the participant receives:

- starting number with a chip for electronic time measurement,
- limited Finisher's T-shirt at the finish line of stage 4,
- Finisher's medal at the finish line of stage 4,
- marking route of each stage,
- GPS track of each stage,
- medical security during the race,
- electronic time keeping,
- online results,
- access to feed zones on each stage,
- access to feed zone at the finish line of each stage,
- Pasta Party - a meal after each stage,
- access to isotonic drink/water tank before the start of each stage,
- the possibility to wash the bike after each stage,
- access to MTB service in the race village.

- 7.1. The entry fee should be paid by bank transfer to the Organiser's bank account or by cash deposit at the Organiser's main office in Jelenia Góra.
- 7.2. Each participant making a payment in the main office receives a fiscal receipt which should be kept. All entry fees include VAT.
- 7.3. VAT invoices for participation fees will be issued by the 15th day of the following month, counting from the date of receipt of funds to the organizer's bank account and only to persons and business

entities that have made the transfer after providing accurate data of the invoice recipient.

- 7.4. For a transfer made with error, the competitor shall bear the costs of possible return in the amount of 50 PLN. (Cost includes: return transfer costs, return form preparation, posting costs, transaction processing costs).
- 7.5. Fees for resignation from the race - in the case of resignation , disqualification or backtracking from the race , the organizer does not refund the participation fee, does not transfer it to another participant and does not rewrite it for the next season. (Article 38 of the Consumer Rights Act).
- 7.6. By paying the entry fee the competitor declares that according to epidemiological situation in Poland, the sports event for which he or she is paying for may be moved to another date indicated by the Organiser. In this case, the participant transfers his/her payment voluntarily to the new date, which will be announced on www.bikeadventure.pl.

8. RULES OF THE RACE:

The number of people competing in Bike Adventure 2023 is limited to - 600 participants.

- 8.1. Bike Adventure will be conducted in 4 stages. The routes of all stages will be marked and secured by the organizer's security service.
- 8.2. The winners of each stage (according to age and open category) will be the competitor who complete the route of the stage in the shortest time, provided that he/she has completed all previous stages.
- 8.3. The winner of the general classification of Bike Adventure 2023 in age category will be the rider who will complete the route of four stages in the shortest time.
- 8.4. The start to each stage in all categories will be from the mass start. The organizer reserves the right to conduct the race in a different way of which the participants will be informed at the technical briefing or before the start of the stage.
- 8.5. The starting area will be divided into 2 sectors. The start order: Sector 1 - top 10 of OPEN K and M, top 3 of DUO classification from the results of the general classification in the previous stage. The start order on stage 1 will be announced day before.
- 8.6. The route will be marked, secured by marshalls, paramedics and policemen.

- 8.7. Checkpoints will be located along the route. Bypassing a checkpoint will be punished with disqualification.
- 8.8. On the route there will be marked feeding points and service points, where participants will be able to make small repairs on their own.
- 8.9. Missing or damaged starting number making it impossible to read by the judges will be penalized.
- 8.10. During Bike Adventure 2023 the Organizer in consultation with the race doctor reserves the right to withdraw a participant whose health condition prevents him from continuing the race.
- 8.11. During the race, the participants are obliged to observe these regulations and the basic rules of fair play.
- 8.12. The time limit for each stage is 6 h 30 minutes for the PRO distance and 4 hours for the CLASSIC distance. Competitors who are on the course beyond the limit will not be classified. They can stay on the route of the stage at their own risk.
- 8.13. Competitors who did not finish one of the stages may continue the race and compete in the next stages, but their results will be included as "out of the race" and will not be taken into account in the stage classifications and the general classification.

9. APPLICATION CHANGES AND TRANSFER OF ENTRY FEE:

Change of distance and transfer of your entry fee to another participant can be made until 30/04/2023.

- 9.1. You can **change the distance** (for example PRO to CLASSIC) only after writing an e-mail to the organizer (message subject: "change of application")
- 9.2. You can **change your general classification** (for example DUO to individual classification) only after writing an e-mail to the organizer biuro@bikeadventure.pl (subject: "change of application") and paying the difference in entry fee in accordance with valid start fees price list (surplus in the entry fee will not be refunded).
- 9.3. **Transfer of entry fee to another competitor** (for any distance and classification) is possible after writing an e-mail to the organizer biuro@bikeadventure.pl (subject: "transfer of entry fee" and paying the difference in entry fee in accordance with the valid start fees price list (surplus in the entry fee will not be returned).

10. AGE CATEGORIES AND PRIZES:

- 10.1. Top 3 of OPEN K and M category (PRO and CLASSIC), after each stage, take part in the official award ceremony.
- 10.2. Other awards and classifications according to the table below.

11. TEAM CLASSIFICATION:

- 11.1. A team entered in the classification may be a formal or informal group of people representing a sports club, association, bicycle shop, town, group of friends, local community, etc. but after acceptance of the character and name by the Organizer.
- 11.2. The team classification is a classification based on the individual results of the participants representing the team.
- 11.3. In the team classification will be classified teams that have registered at least (3) three participants of Bike Adventure 2023, separately on PRO and CLASSIC distances.
- 11.4. The result in the team classification are 3 the best times of the team members obtained in the race on the declared distance.
- 11.5. The sum of the results obtained by the team will be counted to the General Team Classification of Bike Adventure 2023.
- 11.6. It is unacceptable for riders to move from one team to another during Bike Adventure 2023.
- 11.7. The organizer reserves the right to verify the submitted team in terms of its composition and character.

- 11.8. In the general classification of Bike Adventure after 4 stages 3 best teams will be awarded.
- 11.9. The organizer is not responsible for incomplete or incorrectly filled applications e. g. with wrong team name.

12. DUO CATEGORY:

- 12.1. Couples entered into the classification can be: female couples, male couples, mixed couples. Each competitor registers individually, during the registration by choosing PRO DUO or CLASSIC DUO general classification and writing the name of the couple team - the name of the couple team must be the same in the entries of the competitors who want to create a pair.
- 12.2. DUO classification will be conducted separately for female, male and mixed pairs. Participants of the race taking part in DUO are not classified in individual and team classifications.
- 12.3. The result of the pair and the place in the classification depends on the time achieved on the finish line by the weaker member of the couple team.
- 12.4. For the DUO Bike Adventure 2023 General Classification, the results from the four stages will be added together. The winning couple team will be the one which finishes all stages of the race and obtains the shortest total time after four stages.
- 12.5. No passing of riders or any changes in pairs are allowed during Bike Adventure 2023.
- 12.6. The organizer reserves the right to verify submitted couple teams in DUO category.
- 12.7. The organizer is not responsible for incomplete or erroneously filled application.

13. E-BIKE CLASSIFICATION:

- 13.1. It will be run on PRO distance.
- 13.2. Competitors over 18 years old are allowed to take.
- 13.3. "Pedelec" bicycles only comply with UCI regulations in terms of technical and safety aspects, are allowed to compete in the E-Bike Adventure.
- 13.4. Bikes with maximum motor power of 250W, which is gradually reduced to zero after exceeding 25km/h, are allowed to take part in E-Bike Adventure.
- 13.5. On the PRO E-Bike Adventure distance it is allowed to use 2 batteries.

- 13.6. The organizer reserves the right to technical inspection of the bikes before, after and during each stage of E-Bike Adventure.
- 13.7. Prizes and classifications according to the table below:

14. ROAD TRAFFIC:

- 14.1. Bike Adventure will take place with unrestricted traffic.
- 14.2. In particularly dangerous places, the Police and services of the Organizer will facilitate joining the traffic.
- 14.3. Competitors must be especially careful, taking into account the possibility of vehicles driving out of fields, forest roads or single buildings.
- 14.4. All competitors on forest and public roads should drive on the right side of the road and strictly adhere to traffic regulations.

15. PENALTIES:

The Referee Commission in consultation with the Organiser may impose the following penalties:

- Reminder
- Time penalty
- Disqualification

A competitor may be penalized by the Organizer for, among other things:

- not wearing helmets,
- littering (outside feed zones),
- disrespect for the environment,
- equipment deficiencies affecting driving safety,
- failure to observe the rules of fair play,
- unsportsmanlike conduct,

- pushing or pulling the athlete by other persons,
- breaking the rules of the road.

16. ENVIRONMENTAL PROTECTION:

The competitors must respect the environment and absolutely may not pollute the race route, except for the designated buffet zones. Littering the race course will be punished with disqualification. No glass containers are allowed on the competition course.

17. PROTESTS:

Protests concerning the course of the race, classification and results shall be submitted only in writing on the day of a given stage at the Race Office. Protests regarding the results and classification will be accepted for a period of 30 minutes. No protests will be considered after this time. A deposit of PLN 100 must be attached to the protest. The deposit will not be refunded.

18. ADDITIONAL INFORMATION:

18.1. By completing the electronic or paper entry form, the Participant represents that:

- Has read and agrees to the rules and regulations of the Bike Adventure 2023 race,
- He/she is acquainted with the rules of processing of the personal data provided, which are included in these regulations,
- He/she competes at his/her own risk and accepts that participation in the race involves physical exertion and entails the inherent risks and hazards of accidents, the possibility of personal injury and physical trauma (including death), as well as damage and loss of property,
- Filling in the application form and taking part in the race means that the competitor knows the Rules and Regulations, has assessed the nature, scope and degree of risk involved in participation in the race and has voluntarily decided to take this risk, taking part in the race at his/her own risk.
- The data provided is true and acknowledges that the provision of data inconsistent with the truth may result in liability as provided by law.
- The participant agrees that photographs, film recordings and interviews with his/her person (image) as well as results of personal data may be used non-exclusively and territorially by: the press, radio and television as well as for marketing purposes of the Organiser and sponsors of the race in all fields of exploitation related to organisation of sporting events, their

promotion and advertising as well as other undertakings related to physical culture and sport.

- The provision of data is a condition resulting from the conclusion of a contract between the organizer and the participant, in accordance with the General Data Protection Regulation (RODO).

- 18.2. The participant agrees to :
- comply with the rules of the event (lack of knowledge of the rules will not be accepted as an excuse)
 - comply with the provisions of the Road Traffic Code
 - follow the instructions of the police and event staff during the event
 - riding with a rigid helmet over the entire distance
 - using fair play rules
 - to overcome the designated route on one's own (facilitation between competitors, e. g. towing, pushing, etc. , is not allowed).
- 18.3. Any participant who resigns from participation in Bike Adventure during its duration should immediately report this fact in the Race Office under pain of bearing the costs of search action.
- 18.4. The race route may include dangerous sections, steep climbs and descents. It is the participant's responsibility to complete them correctly.
- 18.5. **It is recommended to have adequate insurance.**
- 18.6. The organizer forbids taking part in the race on electric and electrically assisted bicycles - it does not apply to e-bike classification.
- 18.7. The organizer is not liable for any items lost during the competition.
- 18.8. Participants shall bear civil and legal liability for damage caused.
- 18.9. Bike Adventure 2023 will be held regardless of weather conditions with the exception of cancellation of the event due to force majeure, i. e. external events impossible to predict. In this case, it will not be organized on another date. In such a situation, the Organizer will not refund the participation fee.
- 18.10. The organizer reserves the right to supplement the provisions of the regulations, the participant is obliged to familiarize himself with their content immediately before participation in the race. Changes will be posted directly on.
- 18.11. It is forbidden to take photos or make any other record of the Bike Adventure and to distribute materials for sale without obtaining written permission of the Organizer (participants and supporters are

allowed to take photos and publish them only for their own use, not for profit-making purposes).

19. INFORMATION ON PROCESSING OF PERSONAL DATA:

In accordance with Article 13(1) and (2) of the General Data Protection Regulation (RODO), we inform you that:

- 19.1. The administrator of the personal data provided in the application form is Grabek Promotion Sp. z o. o. (Event Organizer) based in Jelenia Góra, K. Miarki St. 42. You can contact us by e-mail at biuro@bikemaraton.com.pl, by telephone at +48 75 76 123 76 or by writing to our registered office address.
- 19.2. We will process the data you provide in the application form in order to :
 - Primarily to fulfil the Agreement we have made with you when you participate in our Bike Adventure sporting event,
 - for information purposes, e. g. event results, press releases,
 - for evidentiary, archival purposes,
 - to make financial settlements, issue invoices,
 - to conduct our own advertising campaigns and marketing activities,
 - to promote our other sporting events, based on Article 6(1)(b) of the RODO.
 - in another justified legal interest (e. g. preparation of tax documentation, handling of the complaint process, investigation of possible claims, etc.), on the basis of Article 6(1)(f) RODO.
- 19.3. The data provided may be passed on to other companies that cooperate with us in the organization of events, e. g. providers of timekeeping services, IT, photography and video services, partners and sponsors of sports events - whereby these companies will process data on the basis of a contract with us, only to the extent and for the purpose specified in point 2.
- 19.4. Your personal data will not be transferred to recipients located in countries outside the European Economic Area.
- 19.5. The personal data provided will be stored for the time necessary to execute the agreement related to the sports event and the entitlements of the participant resulting from the participation in the event, however, not longer than 5 years.
- 19.6. You have the right to access your data and the right to rectify, erase or restrict its processing, the right to data portability in a structured, commonly used and machine-readable format, the right to object on grounds relating to your particular situation.

- 19.7. You have the right to lodge a complaint with UODO if you consider that the processing of personal data violates the provisions of the General Data Protection Regulation.
- 19.8. Providing your personal data is a condition for concluding a contract – and participation in a sport event. The consequence of failing to provide personal data will be lack of possibility to participate in the sport event.
